

COUNTY EMPLOYMENT AND WAGES – THIRD QUARTER 2024

From September 2023 to September 2024, employment increased in 264 of the 369 largest U.S. counties, the U.S. Bureau of Labor Statistics reported today. In September 2024, national employment increased to 155.4 million, a 0.8-percent increase over the year, as measured by the Quarterly Census of Employment and Wages (QCEW) program. Kings, NY, had the largest over-the-year increase in employment, with a gain of 4.9 percent. Employment data in this release are presented for September 2024, and average weekly wage data are presented for third quarter 2024.

Resumption of Publication of Colorado Employment and Wage Data

On November 20, 2024, the Quarterly Census of Employment and Wages (QCEW) suspended publication of industry and substate data for Colorado due to data quality concerns. These quality concerns were due to ongoing issues with the modernization of the state’s unemployment insurance (UI) system. The quality concerns with Colorado data have been sufficiently addressed to resume publication. Effective with this release, QCEW is resuming publication of substate and industry employment and wage data for Colorado. Among the 369 largest counties, 363 had over-the-year increases in average weekly wages. In the third quarter of 2024, average weekly wages for the nation increased to \$1,394, a 4.5-percent increase over the year. Benton, AR, had the largest third quarter over-the-year wage gain at 15.5 percent. (See table 1.)

Large County Employment in September 2024

Kings, NY, had the largest over-the-year percentage increase in employment (+4.9 percent). Within Kings, the largest employment increase occurred in education and health services, which rose by 40,483 (+11.1 percent).


Elkhart, IN, had the largest over-the-year percentage decrease in employment (-2.7 percent). Within Elkhart, the largest employment decrease occurred in manufacturing, which fell by 2,668 (-4.2 percent).

Large County Average Weekly Wage in Third Quarter 2024

Benton, AR, had the largest over-the-year percentage increase in average weekly wages (+15.5 percent). Within Benton, an average weekly wage gain of \$615 (+28.9 percent) in professional and business services made the largest contribution to the county's increase in average weekly wages.

Weld, CO, had the largest over-the-year percentage decrease in average weekly wages (-1.3 percent). Within Weld, an average weekly wage loss of \$722 (-30.2 percent) in natural resources and mining made the largest contribution to the county's decrease in average weekly wages.

Ten Largest Counties

Eight of the 10 largest counties had over-the-year percentage increases in employment. In September 2024, Miami-Dade, FL, had the largest over-the-year employment percentage gain (+1.7 percent). Within Miami-Dade, education and health services had the largest employment increase, with a gain of 5,228 (+2.5 percent). (See table 2.)

All of the 10 largest counties had over-the-year percentage increases in average weekly wages. In the third quarter of 2024, King, WA, experienced the largest over-the-year percentage gain in average weekly wages (+6.4 percent). Within King, information had the largest impact, with an average weekly wage increase of \$903 (+14.4 percent).
